INTRODUCTION & PROJECT AIM

"Environmental crime has become one of the most lucrative criminal activities worldwide. While profits generated by these crimes are high, those involved in such crimes face particularly low risks¹."



These crimes range from wildlife killing and smuggling to illegal waste deposition, and costs society \$ 258 billion per year², alongside incalculable environmental costs to the planet.

The European Network of Prosecutors for the Environment (ENPE), has been set up to tackle these crimes in Europe, and the LIFE-ENPE project has strengthened this network ensuring it can continue to operate and grow.

Its aim is to improve Compliance with EU Environmental Law by addressing uneven and incomplete implementation across Member States through improvements to the efficiency and effectiveness of prosecutors and judges in combating environmental crime. To meet this aim, the key activities have been to

- develop training, guidance and awareness raising material;
- collaborate and co-operate with other enforcement networks, organisations and projects; and
- to communicate and share this information with stakeholders.

PROJECT ACTIVITIES

"The LIFE-ENPE project has enabled ENPE to be formally established as an active, internationally-recognised and respected network of specialist prosecutors - ENPE aisbl. Comprising both prosecuting organisations and individual prosecutors from across Europe and beyond, it has 41 members from 30 countries."

Through the development and promulgation of best practices in fighting waste crime, wildlife crime and air pollution, and in sanctioning environmental crimes in general, ENPE, facilitated by the LIFE-ENPE project, has evolved into an organisation with a central role in shaping EU Policy in combating environmental crime.

- Delivering training materials to over 1000 specialists
- Consulting on EU regulations
- Organised and hosted annual conferences attended by 550 delegates
- Contribution to international networks, groups and projects
- Working Group workshops, guidance and training materials on fighting Waste crime, Wildlife crime, Air pollution and prosecution, sanctioning & judicial processes
- Environmental Crimes database
- Global reach with ENPE members in Latin America and Africa

The project objectives were each achieved on time and within budget:

- 1. Build a Self-sustaining Network of Environmental Prosecutors
- by formally establishing ENPE as an international non-profit association by Royal Decree;
- by expanding the ENPE network from 12 to 41 different organisations and individuals registered as members; and
- by organising and hosting four annual conferences in May 2016, September 2017, October 2018 and October 2019 attended by over 550 delegates in total.

2. Improve the Collation and Dissemination of Information on Environmental Crime

 by publishing a baseline report on environmental crime and prosecution in Europe, and sharing with 41 different countries;

- by the establishment of the ENPE website including the environmental crimes caselaw database; and
- by publishing and sharing 13 ENPE newsletters including all ENPE activity details, updates and case reports.
- 3. Improve Capacity and Consistency in Europe for Combating Transnational Waste, Wildlife and Air Pollution Crimes
- by convening of four specialist LIFE-ENPE Working Groups, providing workshops and training materials to improve the fight against wildlife and waste crime and air pollution as well as sanctioning, prosecution & judicial practice
- by sharing the working group training materials with over 1,000 specialists across Europe;
- by contributing to key EU Policy initiatives to tackle environmental crime.
