ENPE and international collaboration and co-operation

UN Climate Change Conference COP 25 Madrid, Spain 13-14 December 2020

Our expertise was required for a recent high profile global event, as ENPE Board members Antonio Vercher Noguera and Rob de Rijck, together with our Technical Specialist from the LIFE-ENPE Air Pollution Working Group,

Dr Horst Buether, contributing presentations on tackling environmental crime at the COP25 Climate Change conference in Madrid, Spain.

The conference took place under the Presidency of Chile, with operational and logistical support from the Government of Spain enabling the event to be held in Madrid. Four workshops, relating directly to serious environmental crimes with activities



affecting climate change, and aimed at Public Prosecutors were convened with ENPE representatives contributing



specialist presentations on Urban Air Pollution; Shipping Pollution and Pollution from large Power Plants. In addition, they sat on specialist panels discussing the effects of such pollution, and methods of prosecuting illegal activities resulting from such pollution.

This high profile event, which included a keynote presentation from Greta Thunberg, was considered a huge success and the organisers were keen to thank ENPE and our representatives for taking part.

Environmental Compliance Assurance (ECA) forum, 14 February 2020, Brussels, Belgium

ENPE President Anne Brosnan, and ENPE Vice-President Rob de Rijck both attended the most recent ECA forum held in Brussels, Belgium on 14 February 2020.

This important event, the first of the next phase of ECA activities, set out the Action plan on the fight against environmental crime in Europe for the next 2 years. ENPE provided a presentation on recent outputs and our ambition over the Action Plan period, including requirements for resourcing at the conclusion of the LIFE-ENPE project. The next event is planned for the Summer, with the date to be confirmed.



ENPE meeting with Carabinieri Campania Command & Carabinieri Forestali, 20 February 2020, Naples, Italy



Shaun Robinson, ENPE Project Manager and Carla Campanaro, ENPE Supporting Member met with representatives from the Carabinieri Campania Command at their headquarters in Naples followed by a meeting with the Carabinieri Forestali in their offices down in the portside area of the city.

Our hosts at Carabinieri Campania command and at the Forestali offices were extremely



generous, taking time to show ENPE their fantastic training facilities and



discussing the work they do. The meetings focussed around the proposed workshop on the Illegal Killing and Taking of Birds (IKB) in the Mediterranean region, due to be held jointly with the United Nations Environment Convention for Migratory Species (CMS), in Naples in mid-May 2020 (see training venue below).

The coronavirus situation means that this workshop will not now be

able to take place on a face-to-face basis however, it is still planned to hold the

event remotely using webinar facilities. The webinar will include the 'roll-out' of the training pack developed from the Segovia workshop on IKB held in Segovia, Spain in May 2018.We are very grateful for the kindness and hospitality shown by our colleagues at the Carabinieri offices during the visits and wish them well in facing the challenges presented by environmental criminals in and around Naples.

ENPE President Anne Brosnan was the recipient of a Special Award for Innovation in Environmental Enforcement, in particular, for her work on helping to introduce Civil Sanctions in England and Wales and in her leadership role for ENPE. Anne is pictured here receiving this unique award from Lee Paddock of the Environmental Law Institute (USA) and INECE at the AELERT-INECE annual conference dinner which was held at the Adelaide Oval cricket ground.

The Australasian Environmental Law Enforcement and Regulators network (**AELERT**) recently joined forces with the International Network for Environmental Compliance and Enforcement (**INECE**) for the first time to hold a conference focussing on collaboration to improve environmental regulation and enforcement in Adelaide, South Australia.

The conference theme, "Environmental Collaboration: Shaping the

future of regulation, compliance and enforcement together" challenged delegates to consider the ways in which working together and sharing knowledge might contribute to better environmental protection at all levels.

The opening of the conference included an official welcome from an Aboriginal Elder, Major Sumner AM, of the Ngarrindjeri/Kaurna people known as Uncle Moogy (pictured right). In opening the conference, its organisers acknowledged and recognised the historic claims and rights of the first peoples of Australia. They in turn, through Uncle Moogy provided a Welcome to Country explaining the relationship between local people and the land, welcoming conference delegates and setting out their view that all people should tread gently and foster their relationship with the land and the local environment.

The conference provided a unique opportunity for environmental practitioners, academics and leaders in the pollution, wildlife and conservation and marine subject areas to come together to discuss common issues. There were a number of capacity building workshops,



some excellent presentations about the origins and handling of the recent Australian bush fires, water compliance, disrupting wildlife smuggling, intelligence for regulation, illegal dumping and modern regulation to pick out just a few subject areas. There was an interesting panel session on Women in Environmental Regulation which Anne was involved with. All conference papers and presentations can be found on the AELERT website.

Interesting Cases

Urgenda case, Netherlands

The issue in this case was whether the Dutch State is obliged to reduce, by the end of 2020, the emission of greenhouse gases originating from Dutch soil by at least 25% compared to 1990, and whether the courts can order the State to do so.

Fishery owner fined for shooting a protected otter, England, UK

A fishery owner who killed a protected otter to stop it from eating his fish, has today been fined.

Stuart Jones, 54, owned the Lyons Gate Caravan Park and Fishery near Dorchester in Dorset, boasting of wellstocked lakes for people wanting to fish on their holidays.

When local otters found Jones' lakes and started eating the fish, he complained about it to his partner and visitors to the campsite, as he was unhappy about losing valuable fish.

Jones illegally set a trap between to try to catch the otters, because he didn't want to spend thousands of pounds on fencing that would deter the animals from fishing in his lake.

When an otter became caught in a fisherman's net by accident in July last year, Jones used this opportunity to shoot the otter in the head with his rifle.

He did this in full view of holiday-makers, who reported Jones to the UK Wild Otter Trust and to the police.

Jones admitted he had shot the otter despite knowing they were protected. He pleaded guilty to setting an illegal trap and to killing a protected wild animal on 10 February 2020 at Weymouth Magistrates' Court.

Today he has been given a 2 month prison term and our prosecutors are pursuing a confiscation order to deprive Jones of the money he saved by shooting the otter instead of building a fence.

Mark Gammon of the CPS said: "Otters are a well-loved and important part of British wildlife and Jones knew that when he shot the animal he was killing a protected species.

"Jones had plenty of options to stop the otter from eating his fish, but he decided that he would save himself the expense of a fence by shooting the otter.

"He did this with no regard for the otter or the holiday-makers who were witness to this traumatic incident.

"In addition to today's sentence, we are looking to get a confiscation order for the cost of the fencing, which he had saved by acting illegally."

Notes to editors

Mark Gammon is a Senior Crown Prosecutor for CPS Wessex.

On 10 February 2020 at Weymouth Magistrates' Court, Stuart Jones (23/06/1965) pleaded guilty to killing a wild animal contrary to section 2 of the European Communities Act and setting a trap for the purpose of taking or killing an otter. Today he has been sentenced to 2 months imprisonment.

ENPE website crimes database
