#### **ENPE General Assembly 2020 (virtual meeting)**

We were very pleased to welcome 24 of our ENPE Members and Observers to the annual General Assembly on 25 November 2020. This meeting was held remotely using the Zoom platform and was well attended. Anne Brosnan chaired the meeting and gave the President's report. This comprised an overview of all ENPE activities and outputs of 2020. Secretary General, Lars Magnusson, also updated members on the development of the ENPE network over the last 12 months since our General Assembly in The Hague in October 2019, including the addition of four new members from Malta, Morocco, Lithuania and Hungary. We are delighted that the network continues to expand and welcome all our recently joined colleagues.

Another key item on the agenda was the ratification of Ms Aisling Kelly as the new ENPE Treasurer. Aisling is a barrister based at the Office of the Director of Public Prosecution in Dublin, Ireland and has been a Supporting Member of ENPE for a number of years, contributing to the LIFE-ENPE Air Pollution Working Group (WG3). We welcome Aisling onto the ENPE Board.

#### **News from the European Commission**

Our colleagues at the European Commission (DG ENV) have informed us that the EU department responsible for policy on justice, consumer rights and gender equality - DG JUST - has recently conducted a review of the operation of the Environmental Crime Directive and has just published a <u>Roadmap on the revision of the ECD</u>. Interested



stakeholders are invited to comment or provide feedback, which can be done until 30 December 2020. You are encouraged to contribute. Later in 2021, there will be a more focused public consultation, and we will keep you informed on this consultation as it develops.

We would also like to share with you an update on relevant DG ENV initiatives. The information was originally prepared for our colleagues at IMPEL but we believe it may be extremely helpful for us at ENPE and for other enforcement networks. It is not an official document but includes a useful overview of relevant developments. ## **ENPE & CMS training on prosecuting IKB crimes shared**

Following the joint ENPE and the United Nations Environment Programme Convention for Migratory Species (CMS) workshop held in Segovia, Spain on May 2018, a series of awareness raising and training packs were prepared and published. The awareness raising package was shared in January 2020 and is available via the ENPE website. The training slides have recently been shared with all ENPE members and workshop attendees for onward promulgation

to prosecutors dealing with the Illegal Killing and Taking of Wild Migratory Bird (IKB). We hope that both the awareness raising and training packs are helpful to our members and stakeholders and assist in the fight against these dreadful crimes.

## **ENPE** at the UN Convention on Tackling Organised Crime

ENPE President Anne Brosnan recently presented on behalf of ENPE at the UN Convention on Transnational Organised Crime. This was a side event organised by the French delegation, focussing on how organisations and networks might collaborate more effectively to tackle environmental crime. This high profile event was opened by President Emmanuel Macron and include participants from Interpol, the UN Environment Programme, the Global Judicial Institute on the Environment and the World Customs Organisation. #### LIFE Successful Wildlife Prosecution in Europe (SWiPE) Project

This multi-partner LIFE funded Governance, Information and Environment project started on 01 September 2020 with the kick off meeting held in early November. Drawing on experienced partners from across Central and Eastern Europe, the focus is very much on fighting the illegal trade of wildlife in that part of Europe, including specific species of birds, fish and mammals where illegal trade is prevalent.

ENPE will contribute as part of the External Expert Reference Panel, participating in the organisation and delivery of specialist prosecutors training. Shaun Robinson, ENPE project manager, attended at the kick off meeting, outlining ENPE's capacity and experience in this areas and where our network will add value to this important project. We look forward to a fruitful collaboration and the development of strong working relationships with all project partners and stakeholders to strengthen the fight against these illegal activities in the coming months and years.

## Four Networks conference October 2021 – Italy

The Covid-19 pandemic has resulted in the proposed Four Networks conference planned for Italy in September 2020 being postponed now until October 2021. The conference steering group are still very keen for the event to take place on a 'face-to-face' basis, to maximise the opportunities for awareness raising, guidance sharing and networking. With this in mind, by putting the proposed dates back a full calendar year, it is very much hoped that the event will take place in Italy as planned. ## **Interesting Cases**

#### Czech national convicted by Belgian Court for using false documents in court proceedings related to 6 illegally kept Steller's sea eagles

On November 3, 2020, D.F., a Czech national, was convicted in absentia by the Criminal Court of East Flanders, Ghent division, for the use of false documents in civil proceedings concerning 6 Steller's sea eagles.

The 6 Steller's sea eagles were confiscated from H.V.T. He is a bird breeder who has been sentenced to 4 years in prison (2 years suspended) and a fine of 90.000 euro by the Ghent Court of Appeal on 18 March 2016 for illegal trade in protected and endangered birds. An amount of 835.800 euro of illegal gains of the bird trade was confiscated<sup>1</sup>.

He was unable to provide valid CITES documents and only 4 of the 6 Steller's sea eagles were ringed. The birds were seized and confiscated and taken to a wildlife rescue centre. H.V.T. was, however, able to present 6 loan documents for breeding purposes.

The defendant D.F. summoned the Belgian State to a civil court in East Flanders to reclaim the birds referring to the 6 loan documents, certificates of origin, import authorizations, to prove her ownership. This civil case is still pending.

The criminal judge in Ghent decided these pieces were false.

Wiretaps, house searches and computer research in a related case revealed that the eagles were bought at the time by the defendant from the Almaty Zoo at the request of H.V.T. He gave her the money for that. His intention from the outset was to sell the birds. The "loan agreements for breeding purposes" were a fraudulent construction to give the possession of the birds by H.V.T an appearance of legality. Over a 13-year period, D.F. never behave like the owner of the birds. H.V.T. did. In another criminal proceeding, he had requested the lifting of the seizure of the birds, without mentioning that D.F. was the actual owner. D.F. was interrogated under a European Investigation Order.

The court sentenced her in absentia to 1 year in prison and a fine of 16.000 euro for using false documents in civil proceedings.

## A picture on Facebook of a Norwegian golden eagle ended in a prison sentence of 1 year and 4 months.



On 27 October 2020, the Alingsås District Court sentenced a man in his fifties to one year and four months in prison for gross crime against protected species and smuggling. This is the biggest wildlife crime concerning the sale of animal parts of protected species ever investigated in Sweden. The man's passion for the culture of American Natives set him on a path that ended in 200 ads and sales on Facebook and Messenger of bear claws, eagle feathers,

one python skin, parts of a golden eagle, wolf pelts etc. The National Operations Department (NOA) at the Swedish Police Authority and the Protected Species and Cultural Heritage Unit have investigated the crimes.

– This is the biggest wildlife crime investigation concerning the sale of animal parts of protected species ever conducted in Sweden. The sentence is the result of intensive investigative efforts by the Swedish Police, says Public Prosecutor Christer B. Jarlås.

It all started with the Swedish police receiving a case, via the UK police. The UK police had noticed an ad on Facebook of a man, who was later convicted, holding up a golden eagle from Norway. The picture could be found at places such as the Facebook group "Norwegian Indian & Trapper Association". The picture resulted in a house search conducted at the address in Värnamo, Sweden, where the suspect was registered. The suspect no longer lived there, but many of his belongings were still there and were searched. Nothing was seized.

The suspect was called in for questioning at the police station on Borås, Sweden, along with his public defence counsel Marie Abrahamsson. During the questioning, it emerged that the suspect lodged with his cousin. He also stated that there were objects of his that were assessed as being of interest to the investigation. In parallel to the questioning, a search of premises was carried out with the assistance of local police. Seizures were made of several animal parts belonging to CITES-listed animals. When the police investigators came back from the questioning, a new search was conducted on Patrick Persson's Facebook, and another ad for a python skin was found. In addition, because the documents they needed did not exist, the smuggling of the golden eagle from Norway into Sweden was also investigated.

#### -New crimes were discovered

When the investigation of the first case was almost completed, the suspect's Facebook account was checked again and 258 new ads containing CITES-listed animal parts were found and a new case was set up. 175 of the ads above remained in the case and in 113 of them objects were found and seized. In September 2017, the suspect was called in for questioning at the police station in Alingsås, along with his public defence counsel. In connection to this, another search was conducted, this time of his car and at his new address. Further seizures of CITES-listed animal parts were made, inside his vehicle as well as at his new home. Following the extraction of data from his mobile phone, two sales of CITES-listed animal parts were revealed and subsequently linked to the suspect's bank account.

#### -Mutual legal assistance in the United States

In October 2017, a request for mutual legal assistance was sent to the United States, to a US prosecutor, in order to extract data from Facebook and Messenger, via a US court, and in November 2018, a CD record containing the extracted data was received from Facebook and Messenger. On it were found four sales that could be linked to the suspect's bank account in 2015 and 2016.

Experts were brought into the investigation. The birds and mammals section at the Swedish Museum of Natural History along with an independent ornithologist determined the species of the animals shown in the ads including the seizures made in the case of animal parts, claws and feathers. An age determination of the golden eagle and wolf pelts using the Carbon 14-dating technique was made at the Ångström Laboratory in Uppsala University, and an expert from the Swedish Board of Agriculture explained the formal requirements in line with the regulatory framework.

In all three cases, a final interview was conducted in October at the police station in Alingsås. Charges were brought in January 2020. The trial lasted five days in the Alingsås District Court in September 2020. Both the public prosecutor and the police investigators were present during the whole trial. The sentence was handed down on 27 October 2020. The suspect was sentenced to one year and four months' imprisonment for gross crime against protected species and smuggling. Most of the items seized have been forfeited. Deadline for appeal is three weeks from the pronouncement of the judgement.

As always when it comes to wildlife crime, the complex legislation places high demands on the investigative process and the presentation before the court. In this case, there were both A and B-listed species in accordance with the EC convention 338/97. But the judgment is clear and pedagogical and will be a useful tool in these cases in the future, says Christer B. Jarlås.

# Builder fined £600,000 for destroying bat roost in south London, UK

Court hands Bellway Homes largest ever wildlife crime fine after it admits demolishing site in Woolwich

A building firm that carried out demolition work at a site known to be inhabited by bats has been handed a £600,000 fine, the largest ever issued by a court in the UK for a wildlife crime, according to police.

Bellway, the housebuildlers, admitted damaging or destroying a breeding site or resting place in Artillery Place, Greenwich, south-east London, in 2018, where soprano pipistrelle bats had been documented the previous year.

All species of the animal in the UK are protected.

Bellway, which also had to pay costs of £30,000, agreed to make a £20,000 donation to the Bat Conservation Trust, the Metropolitan Police said.

Inspector David Hawtin praised Sgt Simon Henderson and PC Giles Balestrini for their roles in the investigation.

"With the expert assistance of colleagues from specialist units within the Metropolitan Police, the officers constructed evidence to prove that the company had indeed committed an offence by carrying out work at a site where bats were known to inhabit," he said.

"Bellway Homes has admitted responsibility for this and I hope it reinforces the message that this legislation is there for a reason and should be adhered to."

At Woolwich Crown Court on Tuesday 8 December, the company pleaded guilty to damaging or destroying a breeding site or resting place of a wild animal of a European protected species between 17 March and 17 August 2018.

The company had been notified in planning documents that it would first need to obtain the appropriate mitigation and a Natural England European protected species licence.
